Better access to bus stops i.e. nearer to retirement village and care facilities. Covered bus terminal in town preferably with buses all on same side of street or under one roof (see ChCh as an example). More thought overall to new housing subdivisions. need roading, water, power etc that's able to cope with existing and new developments BEFORE THEY ARE IMPLEMENTED (Do it right do it once)

Wish to speak to the Council: No

My basic concern is with annual rates increases of near 10% our rates are going to double every 7 years which for many is a burden that they can ill afford. I realise and support the need for providing funding for the maintaining the assets of the city at a high standard and for some new projects to improve our way of life and these rate increases seem to exceed this brief greatly.

I see no white elephant projects like the \$80 million that was spent on rugby park that will get limited use. We have got a preferred events venue in the Bowl and have dropped far down the pecking order for rugby tests or other major sporting events while NPC struggles to draw crowds and is financially not doing great. North Harbour rugby can't afford to use North Harbour stadium anymore and have shifted to a smaller ground.

So, what is underlying this large increase in spending.

I came across an article From the Taranaki Daily News of an interview with Neil Holdom on the Patterson Road Development which is roughly 75% of the new built houses needed to house the extra 1000 new residents a year for the city for each year. The \$11 million project was subsidised by rates and taxes worth \$8 million. This is only to connect into the existing system and further infrastructure work would be needed for pedestrian, cycle and road links. Then there was the upgrade needed to the Veale Road pump station to meet growth, a new gravity sewer main from Frankly Road to Sutherland Park required for this area. Other expansions are going to require sourcing and constructing new water supplies, storage facilities, treatment transmission etc etc

Elsewhere when pipes are replaced and the requirement has increased and if the pipe size needs to increase from say a 150mm pipe to a 200mm pipe then you are doubling the cost of the project as a example of an added cost.

There are tipping points which are happening, and with increases, new everything is needed and because prior councils have not considered expansion in the future and put aside land or protected resources such as new water supply resources for future generations our opportunities for expansion are limited and are becoming exponentially expensive. Neil says up to \$90,000 per section for new plumbing infrastructure is the cost to council.

In New Zealand 5 mil people, we have 4.5 mil registered vehicles. Two per property. Do a count on your street. 300 houses mean's another 600 cars from Patterson Rd alone, and many more to be added with each future development. Tukupa Street is overload most of the time now as are most of the arterial routes. Travel times from point to point around the city are getting longer rapidly. Blagdon to Bell Block the other day took 30 minutes. Waitara use to be 20 minutes. A ring road is great but no one has put aside greenspace, and housing development has extended even today up what you are hoping to use as arterial routes such as Carrington St in the future. Which is limiting where a bypass road can go cheaply. Housing in Europe in not found on most new arterial routes. This is a tipping point, and whether the Government pays or the Councils it is the people that pay. The cost is going to be I believe conservatively \$1.5 billion plus and you will be standing in line with every other mayor in the country. Whangaparaoa has just received approval of finance of \$840 mil for a new motorway and that will be over full in twenty years according to Auckland roading engineers. They will be needing another new motorway as well, but also the Northern motorway by then will need an extra 3 lanes and maybe a new harbour bridge which will overload the Southern motorway. Aucklanders at present spend on average 5 days in their cars each year due to delays according to the NZ Infrastructure commission report and we are going to join them. Nelsons new

hospital just built at a cost of \$1.2 billion to meet capacity for 30 years will now be too small for the population when it opens now due to population growth.

The council is now regularly spending a million here, \$5 million there, on our arterial routes for incremental safety improvements that were not needed 10 years prior due to less traffic. To help the equation you are trying to ram a bunch of cyclists into this mix as well. In Europe for example a route like Devon St west would not be considered as a suitable route to put a bike lane on, but using Young St, Gaine St, West End, Devon school, St Joeseph School, Moulton St Lowry St reserve Skinner St, Ngamotu Domain would be a low car area as the route that would have priority of cyclist over cars. The European standard on this is to have 100% separation of vehicle, cyclist and pedestrian where bike lanes border starts at least a 2 metre gap away from the roadway and a good gap also to pedestrians

For safety no school should have an entrance onto an arterial route but onto a side street. Spotswood's schools should alight onto Omata Rd or by a pedestrian tunnel to Ngamotu Domain.

In the old days for a water supply you placed a weir over a stream, ran a pipe and that was all that was needed for 50 years. Land was cheap and vacant of structures and expansion was cheap. No rules, no regulations so expansion was cheap. It was pretty much the rule till the 1970's. Today it's the total opposite with water, sewerage, stormwater, gas, telephone, fibre, electricity competing for the same space under roads footpaths and bike lanes. Life is complex and complex is expensive.

There is no room to widen arterial routes which are grinding to a halt. There is no space for new roads. Even minor improvements are extremely expensive. The city hasn't been deigned with a central accessway and the ability to attached new modular sections to at a similar cost. Planning has been ad hoc and anything new is having serious repercussions on what is already there. Any addition is exponentially more than the previous and rate payers cannot afford financially the cost, and also having to see the easy lifestyle of the city which they desire disappear.

Expansion has got expensive. \$90,000 council for plumbing per section or a total of \$36million per year (400 sections) for Plumbing alone then chuck in the tipping point costs of congestive roads crowded libraries, playgrounds etc. Expansion in the past was cheap and now is expensive and the more we expand the more expensive changes will become.

A group at Canterbury University in 2017 came up with the figure of \$180,000 (maybe \$250,000 plus today) as the amount of shared infrastructure they needed from day one. \$250,000 for 1000 new residents is \$250 million in new development a year with a large amount split between central and local government. I suggest that \$100 million is our local burden. I suggest that a levy of \$250,000 be placed on each section to pay for the true cost of the infrastructure that they require. I know not many sections would sell but we still win as the new infrastructure would not be required. We would have a saving of 1 billion in infrastructure cost over 10 years which would go some way to containing the rates increases

With the extremely high cost of providing extra services the ratepayers cannot afford them anymore. With more cars etc we are quickly grinding to a halt and will soon be joining the ranks of Auckland, and now Tauranga that have major congestion problems. Tauranga is now starting to drop down the list of the most desirable place to live as the lifestyle has been eroded badly. As a place to live New Plymouth has been a great place to live and user friendly but that lifestyle is being eroded rapidly.

Kawaroa Park development

At present there are 100 parking spaces and the playground is going to increase to be 9 times larger and there are still only going to be 100 parking spaces being provided in the plan with the next nearest parking in both direction of 1 kilometre. I pass through this area regularly and the car park reaches near capacity often with the Squash Club, swimming pool and playground as well as day parking for workers. Few will walk a kilometre with a group of young children to a playground and have to pay for metred parking. First world problem.

Brooklands Zoo

Most of the cliental there are young children under 8 as the playground equipment would indicate. They don't care what the animal is. Just that there is an animal. What I am suggesting is a good petting zoo that reflects the agriculture base of our area. You are taking about a budget of \$9mil which could fund an operating farm near town that could provide feed for the animals, and animals on rotation basis and be totally self-future funding Maybe show a cow milked every two hours and other farming activities and an opportunity to get up close and personal with a range of animals. Just a thought. Overseas we came across a great petting zoo that was extremely popular with a lot of interaction.

Climate Change

The OECD Material Outlook 2011-2060 report states that population and material use are the two main drivers of Greenhouse gas increases and that if we continue our present path, population will increase by 25%, and material use will double in this period, causing emissions will increase by 50%. The aim of a 47% decrease by 2030 is a joke and the Secretary General of the UN states that by 2030 emissions will have increased by 14%. This is after a large discount for science and innovation and change in employment types. So far, the world is exceeding their predictions and New Zealand Infrastructure report suggest we are leading the pack. NPDC plan appears similar.
