- · By other means.

The following limitations apply:

- 1. All nominations for a citizens' award must be submitted using this form.
- 2. Nominations are confidential between the nominator/seconder and NPDC.
- 3. A maximum of 12 awards will be presented each year.
- 4. If the nominee has received payment or other remuneration then NPDC will determine whether, in its view, the nominee's action was carried out as part of their remunerated responsibilities or was sufficiently beyond the call of duty to warrant special recognition.
- 5. Current serving political figures, including district councillors and community board members, are ineligible.
- 6. If multiple nominations are received from the same organisation usually only one award will be given.
- 7. Nominees must normally live in New Plymouth District. NPDC has discretion to present awards to non-residents.
- 8. Councillors or community board members can nominate up to two recipients each year.
- 9. Nominations from a nominee's immediate family will not be considered.
- Nominations received after the nomination closing date of 12 July 2023 will not be considered.
- 11. If a recipient is subsequently found guilty of an offence punishable by a term of imprisonment of two years or more that person will be notified immediately and their name will be removed from the Citizens' Awards honours board without delay.
