Junction Road Endowment Fund

Background

On 1 June 2010, the Council approved the sale of the 25 NPDC-owned Junction Road Leasehold Endowment Properties.

The freehold interests in 24 leasehold land farm properties made \$7.68 million in sales.

Taking into account the interest this fund has generated long with expenditure on completed projects, there is currently \$7.65 million in the Endowment fund Trust.

In accordance with the conditions of the endowment, the funds are used for maintenance and improvement works on Junction Road (now Tarata Road) and other roads in the former Taranaki and Inglewood Counties, excluding Inglewood itself.

Consultation

In May 2013 it was agreed that consultation would be undertaken with the affected landowners/residents to consider their views and preferences on the draft 10-year Road Maintenance and Improvement Works Programme.

A survey was undertaken of residents and road users and community meetings were held in Tarata and Inglewood. A further meeting was held at Kaimata Hall to provide feedback on the outcome of the survey on 17 September 2014.

Any projects that qualified for Waka Kotahi NZ Transport Agency funding assistance were removed and placed under general improvements and maintenance budgets. At every meeting held, the issue of how the money was to be spent was raised. Those present were consistently advised that if they wished to change to how the funds were used, they would need to make this known to the elected members.



Junction Road Endowment Fund

The Junction Road Endowment Fund works plan was developed with the community in 2015.

Dates for construction were amended in 2020.

Please note that construction dates are subject to confirmation of final scope/design and detailed cost estimates.

Priority Project 1 (Slippery Hill) requires a change in the Council resolution to be able to fund this project.

At present only interest on the Junction Road Endowment Fund is spent and each project has a 51% subsidy from Waka Kotahi.

The works plan is reprioritised every three years and other sites that need to be considered from a road safety perspective are added. Following the reprioritisation, a community meeting will be planned to discuss the works programme for the next three years commencing 1 July 2024.

Projects Completed in 2023/2024:

Earthworks and entranceway upgrade for Ngāti Maru Marae (not in original programme).

Projects Planned for 2023/2024:

Tarata Saddle road safety improvements.
