



## MEMORANDUM IN RELATION TO APPLICATION NUMBER SUB24/50201.01

1. The purpose of this memo is to clarify the number of submissions received for application SUB24/50201.01 and how those submissions were recorded in the section 42A officer's report dated 22 May 2026.
2. Table 5 of the section 42A report states that the submissions received were as follows:
